Checklist

Bring the following items if applicable to you

- List of Colleges and/or Universities the student is interested in attending
- Student's driver's license number
- Student's alien registration card, if the student is a legal permanent resident
- Student and Parents'/Guardians' PIN Number for FAFSA application
- Student and Parents'/Guardians' Social Security Number
- Student and Parents'/Guardians' W-2 Forms and other records of money earned in 2014
- Student and Parents'/Guardians' 2014 untaxed records (Examples: public assistance benefits)
- Student and Parents'/Guardians' 2014 bank statements
- Student and Parents'/Guardians' 2014 business and Investment mortgage info and other investment records

If you have already filed your 2014 tax return, please bring a copy of it or the tax return transcript! This can speed the process up significantly!
